In view of the strategy under New Industrial Policy the Gujarat Government has introduced 'Scheme for Assistance for start ups/ Innovation' vide its Resolution of Industries and Mines Department, No. MIS-102014-924909-I dated 27.01.2015. The Education Department (Higher and Technical), Government of Gujarat has published STUDENT STARTUP AND INNOVATION (SSIP) POLICY (2017-2021). A special focus under SSIP has been given on IPR protection and leveraging its impact.


The institute shall utilize the grant for students' start-ups for the following activities:

- Prototype support
- Patent support

- c) Activities, such as documentation, dissemination, creation of preincubation facility, conferences, hackathons, academic courses of startup and innovation, short-term training programmes, other pedagogical and academic interventions and other operational expenditure.

The funds under the SSIP shall primarily be utilised for helping students producing a proof of concept, designing, filling patents and assist them on activities such as conducting workshops and programmes.

Upon receiving an idea from students, the above mentioned committee shall evaluate the idea to check whether the idea is feasible in the market or not. Once the idea is validated by the SSIP committee of this institute, the students can avail necessary guidance from the committee to produce necessary patent filing documents or to register the design for copyright, trademark, design registration, etc. The students can avail appropriate funds for prototype building and patent filing. In Gujarat, a sum of Rs. 15,000 approximately is required to file a patent.
